

# 2023-24 REGISTRATION INFORMATION

## KINDERGARTEN & TRANSITIONAL KINDERGARTEN

### CLASS OF 2036 AND 2037

Kindergarten: Student must reach five (5) years of age on or before September 1, 2023.

Transitional Kindergarten: Student turns five (5) years of age between September 2, 2023 – April 2, 2024

### What do I need to register my student?

1. Student's Birth Certificate
2. Driver's license of birth parent/legal guardian
3. Proof of Residence – Must be in birth parent/legal guardian's name and be one item from the list below.
  - o Recent PG & E bill
  - o Recent water, sewage or gas bill
  - o Current rental agreement
  - o Recent property tax payment receipt
  - o Recent pay check stub
  - o Escrow papers which verify closing date within 45 days
  - o Voter registration card
  - o Certified copy of the voter application form
- a. If you do not have proof of residence in your name, you will need to bring the person whose name is on the bill with you at the time of registration. There is an additional form you will need to complete.
4. Immunization records – for a complete list of immunization requirements, go to: <https://www.cusd.com/immunizations.aspx>
5. Any court documents which pertain to student and custody issues

### Who can register my student?

1. Biological parent or legal guardian/custodian of student. Remember, legal guardian and/or custodian must present court order at the time of registration.

### FAQ's:

1. What day is kindergarten registration?
  - a. Online registration will begin on February 22, 2023 at 10:00 am. Any registrations entered prior to 10:00 am will be deleted so please make sure you wait until then to start the registration process. Go to: [www.cusd.com](http://www.cusd.com) for the registration link.
  - b. Appointments in which your registration will be finalized will begin on Wednesday, March 1, 2023.
2. Is registration for transitional kindergarten held at the same time?
  - a. Yes
3. What is transitional kindergarten?
  - a. A two-year program which introduces our younger students to the kindergarten curriculum. Students whose birthday falls between September 2, 2023 – April 2, 2024 are automatically qualified for transitional kindergarten.
4. Is transitional kindergarten required?
  - a. No, but you will not be permitted to enroll your student until the following year when they qualify for kindergarten based on their age.
5. We purchased a home in the Young Elementary area, but our escrow will not close until late August, September, etc. Can we still register our student at Young for the 2023-2024 school year?
  - a. No. You will need to register at your home school and then request a transfer from Student Services & School Attendance (SSSA) if you would like your child to start the 2023-2024 school year at Young Elementary. Please remember, this is not a guarantee of approval.
